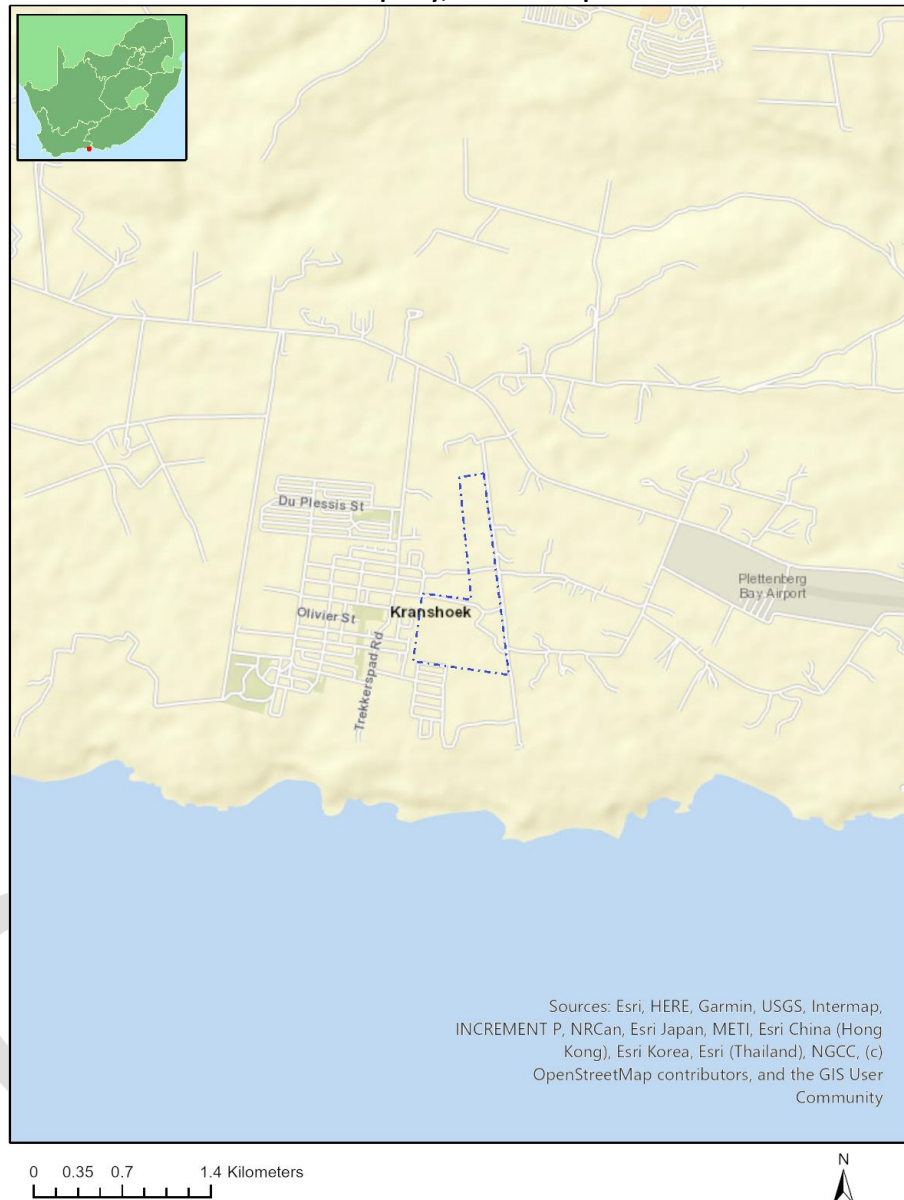

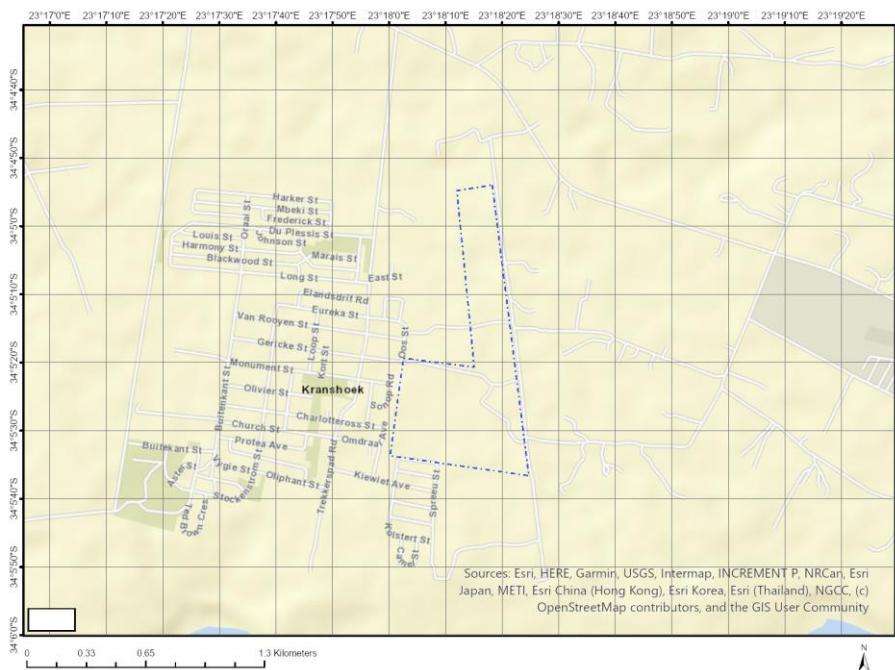

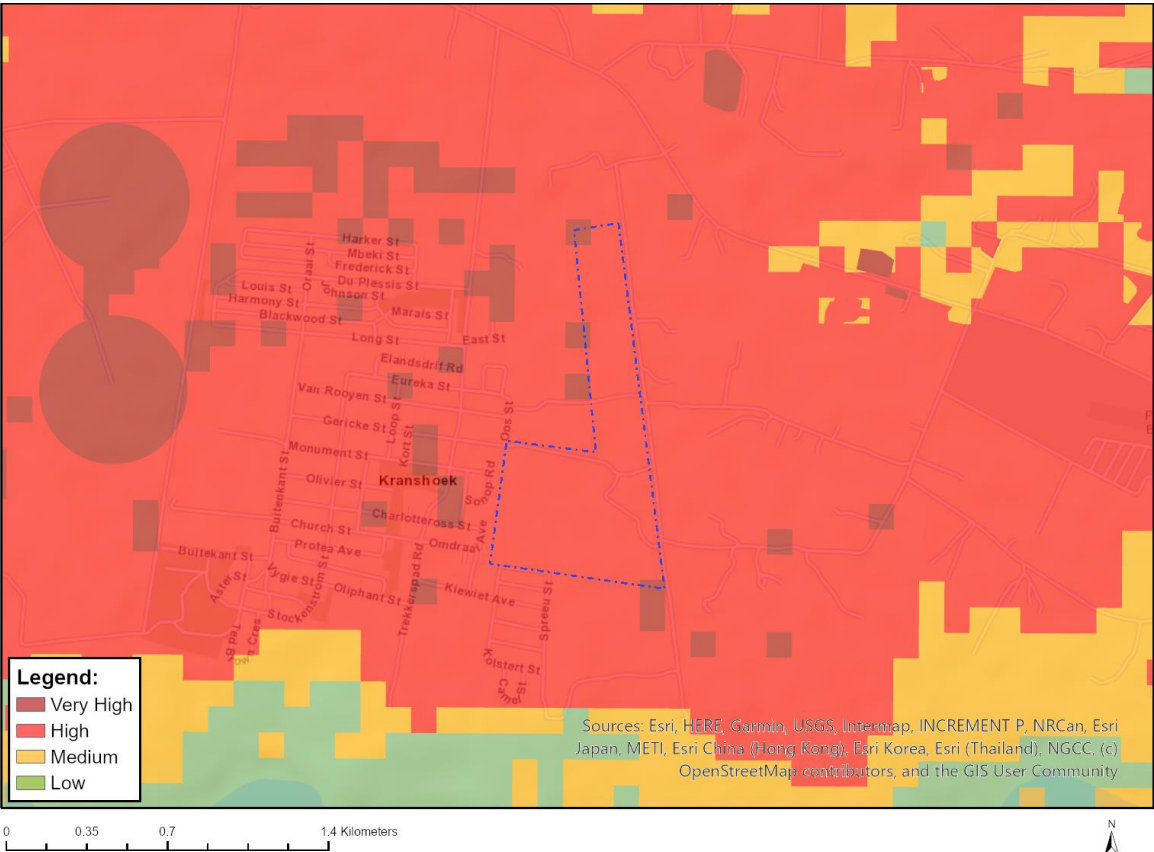

MAP OF RELATIVE AGRICULTURE THEME SENSITIVITY

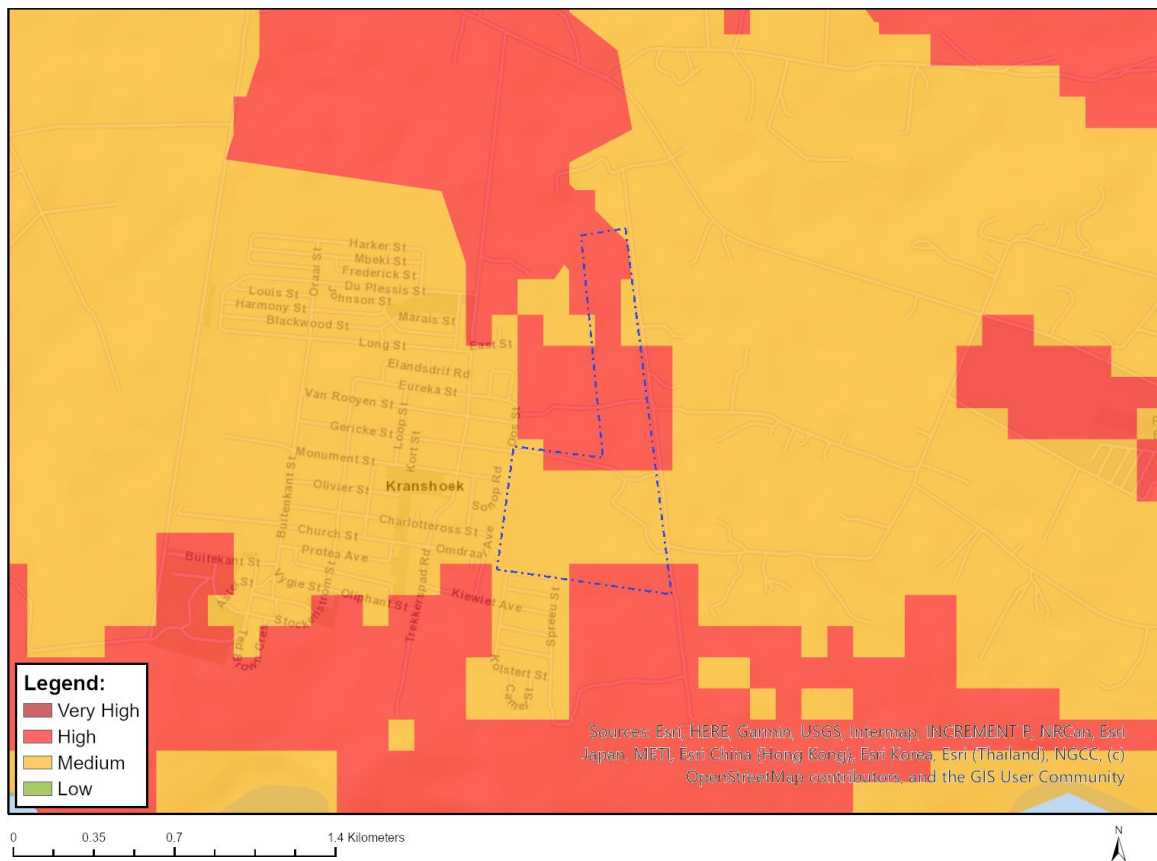

MAP OF RELATIVE AQUATIC BIODIVERSITY THEME SENSITIVITY

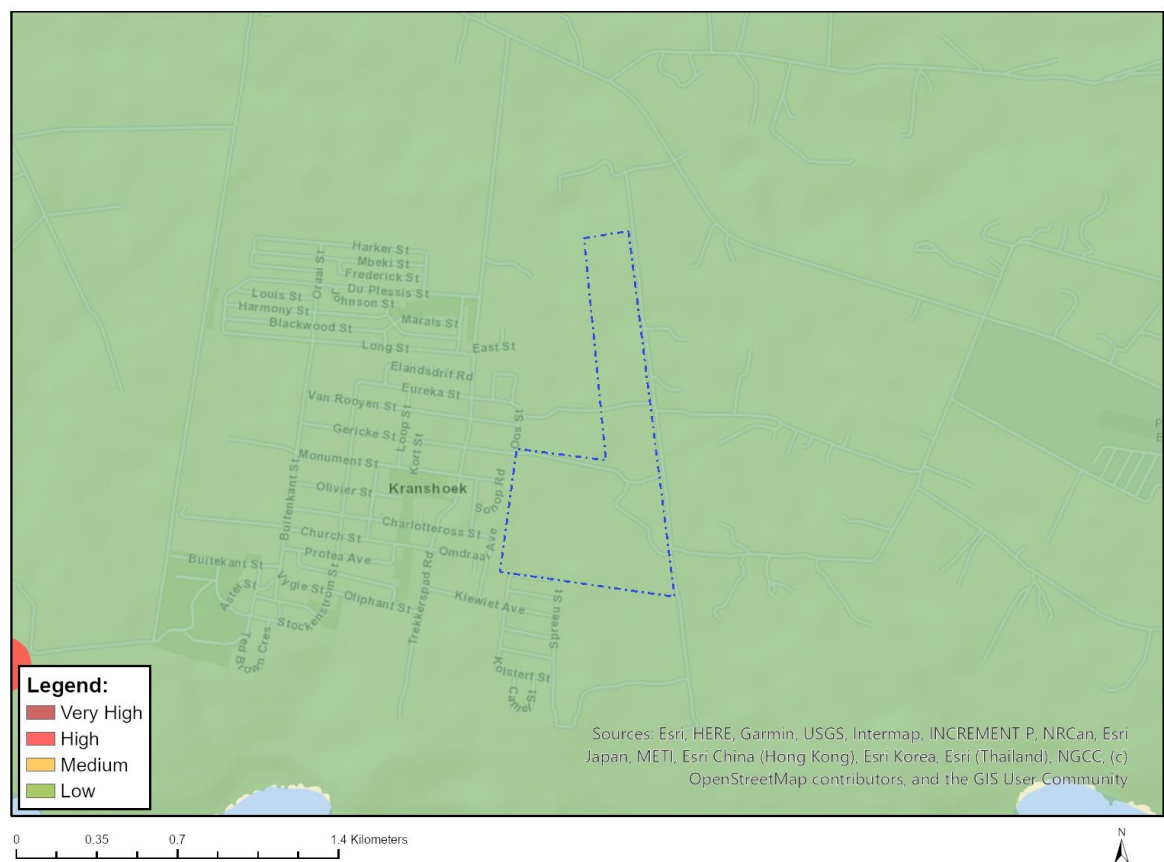

MAP OF RELATIVE CIVIL AVIATION THEME SENSITIVITY

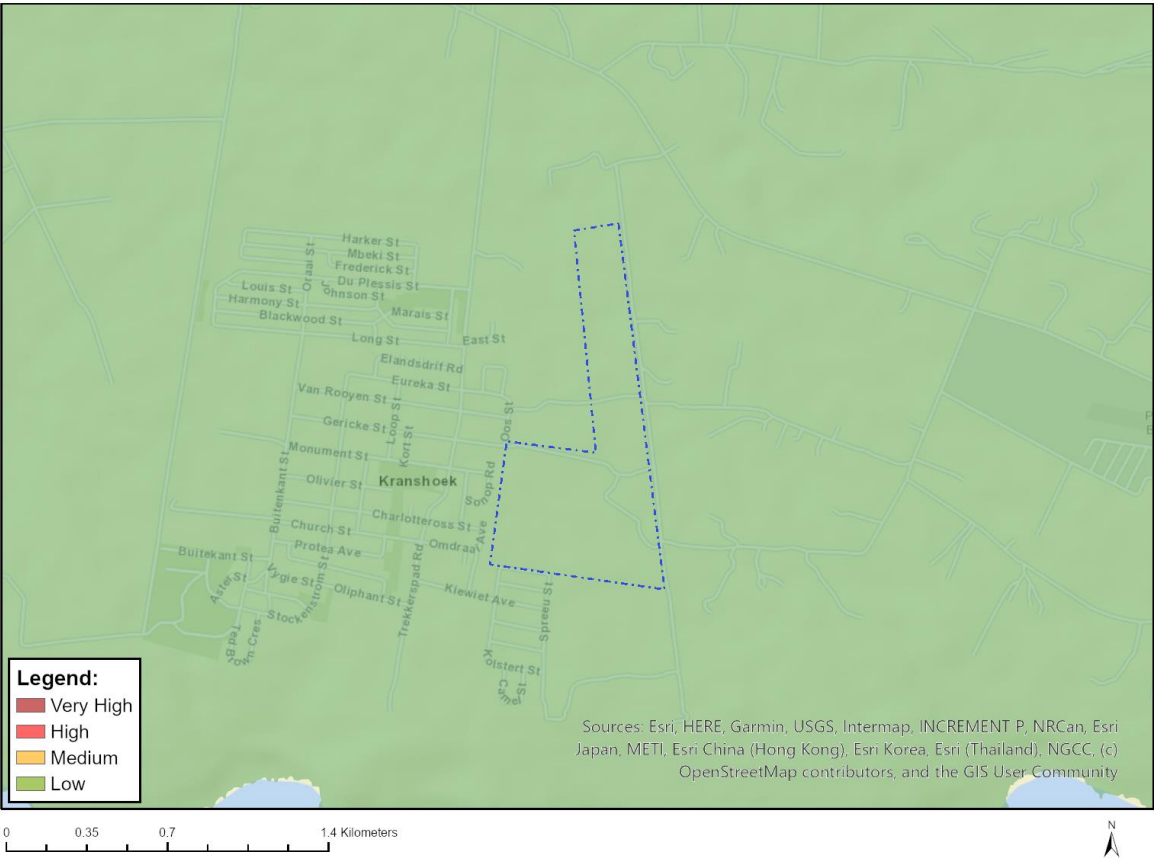

MAP OF RELATIVE PALEONTOLOGY THEME SENSITIVITY

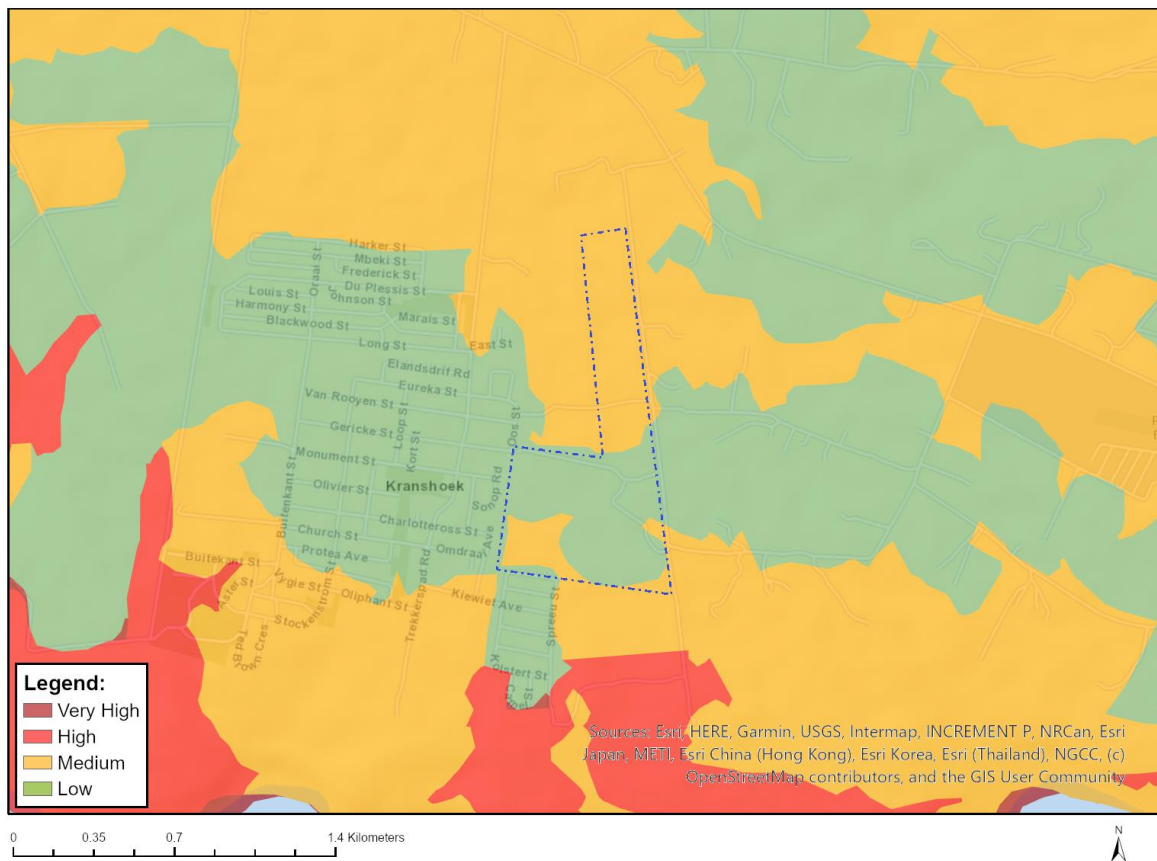
