Dortmund sign Chukwuemeka from Chelsea until 2030

BORUSSIA Dortmund's summer Premier League recruitment drive continued yesterday with the signing of midfielder Carney Chukwuemeka from Chelsea until 2030.

England under-21 representative Chukwuemeka, 21, joins for a reported fee of 25 million euros.

He spent the second half of last season at Dortmund on loan, staying on as the club made the quarter-finals at the Club World Cup.

Chukwuemeka played 17 times for Dortmund in all competitions, scoring once and impressed despite struggling with injury.

Born in Austria, Chukwuemeka moved to England at a young age and came through Aston Villa's youth academy before signing with Chelsea in 2022. Dortmund also signed Jobe Bellingham from Sunderland and Yan Couto from Manchester City this summer. | AFP

Were Boks pulling punches with Eden Park on horizon?

IN 2018 and 2019, it was clear that Rassie Erasmus and the Springboks prioritised their away matches against the All Blacks.

In 2018, the Boks won their opening Rugby Championship match against Argentina at home before being hammered by Los Pumas away in Mendoza. A week later, the South Africans lost to the Wallabies in Brisbane, and people were already starting to speculate about Erasmus' future — seven games in, with three wins and four defeats to his name.

Heading into their next match against the All Blacks in Wellington, Erasmus said: "If we do really bad here, then I will probably not be in the seat for the next couple of matches and somebody else will probably be."

At the time, as journalists, we took it at face value. It genuinely seemed as though he was completely stressed and already worried about his job. It was reported as such, with the feeling that Erasmus may have underestimated the size of the job ahead of him.

But the Springboks produced one of the great performances by an opposition rugby team on New Zealand soil, coming out on top by playing a complete brand of rugby. Erasmus ended up keeping his job, and a year later, the Springboks won the Rugby World Cup in Japan. Having covered the Boks and Erasmus over the last seven years, and knowing to expect the unexpected when it comes to the Bok coach, I asked myself if he was really going to resign or get fired if he had lost to the All Blacks. Probably not.

But it's interesting, looking back now, that they threw all their eggs in that basket for

that match — and indeed the following year's clash against the All Blacks, which ended in a dramatic draw in the New Zealand capital.

For Erasmus, those matches were about laying down a marker for the World Cup in Japan. It was about getting that belief that they could compete with and beat the best in the world — which, of course, were the All Blacks.

Everything leading up to that match was about the theatre that Erasmus creates, knowingly or unknowingly.

In the lead-up to the Boks' game against the All Blacks in 2018, they were flat and uninspiring. They didn't reveal much about how they were going to play or what tricks they were going to come with.

Fast forward seven years, and there are a lot of similarities in how the Boks have gone about their approach at the start of this year's Rugby Championship, ahead of a really big match against the All Blacks at Eden Park.

Besides the spectacular 20 minutes of rugby against the Wallabies at Ellis Park, the Boks haven't really given us a glimpse of what to expect at Eden Park. They have hardly mauled over the last two weeks, with their first attempt from a lineup in Cape Town coming in the 55th minute.

The backline shape has been pretty standard, with no real moves out the back — just passing from side to side. Essentially, there was only one midfield lineup during the two matches, with the Boks doing one for what looked like amusement at Ellis Park.

Many people would agree that the Wallabies played some great rugby and that they have improved out of sight since the last World Cup. But we must also agree that the Boks seemed to be stuck in third gear, following two uninspiring performances.

Or maybe they are just playing within themselves ahead of the Springboks' biggest clash between now and the World Cup — the cards close to the chest, as Erasmus looks to make another big statement in New Zealand.

History is certainly on the line, as the All Blacks haven't lost at Eden Park since 1994. Everyone knows what's at stake — none more so than Erasmus.

Well, we have under two weeks before we find out if the Springboks are going to throw their biggest punches against the All Blacks to make history at Eden Park.

SA top seed Harris books second-round date with Fritz

SOUTH Africa's top-ranked men's tennis player, Lloyd Harris, booked a place in the second round of the US Open against No 4 seed Taylor Fritz today after the qualifier stunned 39th seed Sebastian Baez with a straight sets 6-3, 7-5, 6-4 victory in Monday's opening round.

Harris, ranked outside the top 300, served well to win 80% of the points behind his first serve against the Argentinian, and won 53% of points on his second serve.

The 28-year-old converted 55% of the break point chances he created.

At the end of the match, Harris won 103 points while Baez won 75. He won an impressive four games in a row to see out the match after being broken early in the third.

His reward is a match against American Fritz, the equally big-serving baseline player who was beaten in last year's final at Flushing Meadows by current world No 1 Jannik Sinner of Italy.

Fritz accounted for US wildcard entry Emilio Nava with a 7-5, 6-2, 6-3 victory in his opening match.

It will be the third time the South African ace will face 27-year-old Fritz, with honours even after their first two encounters.

Harris is on the comeback trail, ranked 353rd in the world after a nightmare injury spell that required two major surgeries.

His progress this year has been steady, reaching the first round at the French Open and the second round of Wimbledon. On both occasions he fell to Andre Rublev of Russia, pushing the world No 15 to four sets at SW19.

He again fought his way through a gruelling qualifying campaign at Flushing Meadows in New York, beating Spain's Daniel Merida Aguilar to seal his spot in the US Open main draw, before seeing off Baez in the first round.

The nature of the victory over the clay-court specialist will no doubt please the South African, whose best Grand Slam performance came at the US Open in 2021, when he reached the quarter-final on his way to a career-high ranking of 31.

He will need to be at the peak of his powers to have a chance of an even bigger upset against Fritz.

The No 4 seed and young hot shot Ben Shelton carry American hopes of ending a 22-year men's Grand Slam singles drought on home soil.

Pérez, Bottas named for 2026 F1 debut

CADILLAC have fired the starting gun on their Formula 1 journey, confirming Sergio Pérez and Valtteri Bottas as the drivers who will lead the American marque onto the grid in 2026.

It's a bold move that brings together two veterans with race-winning credentials and the kind of experience a brand-new team desperately needs.

CHECO'S NEXT CHAPTER

For Sergio "Checo" Pérez, this is more than just another contract – it's a career revival. The Mexican ace has been part of F1 since 2011, carving out a reputation as one of the sport's sharpest operators on race day.

His early days with Sauber and Force India showcased his uncanny ability to manage tyres and drag midfield cars into podium contention.

The world really took notice in 2020, when Pérez stormed from the back of the grid to win in Bahrain – a victory that landed him a seat with Red Bull.

Partnering Max Verstappen, he added more wins to his tally and even finished second in the 2023 championship.

By the time Red Bull cut ties in 2024, Pérez had cemented himself as Mexico's greatest Formula 1 driver. Now, Cadillac gives him the chance to lead a fresh project and fly the flag for Latin American fans eager to see him back at the sharp end.

BOTTAS BACK FOR MORE

Alongside him comes Valtteri Bottas, the

calm, unflappable Finn whose career has taken him from Williams rookie to Mercedes stalwart. Signed in 2017 as Nico Rosberg's replacement, Bottas thrived under the pressure cooker of Mercedes' dominance. 10 wins, countless podiums, and a crucial role in securing constructors' titles proved his value, even if he spent much of his time in Hamilton's shadow.

Bottas later moved to Sauber/Alfa Romeo, where he took on a mentoring role before slipping into a reserve job with Mercedes in 2025. Just when it seemed like his race career might be winding down, Cadillac came calling.

For Bottas, it's the perfect lifeline: a chance to lead development, score points, and remind the paddock of his raw pace.

WHY EXPERIENCE MATTERS

Cadillac could have gambled on rookies or homegrown American talent, but instead they've played it safe – and smart. Pérez and Bottas bring over 20 years of F1 know-how, a combined 16 Grand Prix wins, and a reputation for professionalism.

In the high-stakes world of f1 car development, that kind of stability is gold dust. The question now is can Cadillac hit the ground running against the sport's giants?

With Checo's racecraft and Bottas' consistency behind the wheel, fans might be about to witness the birth of Formula 1's next great underdog story.
