### IMPORTANT INFORMATION ABOUT EMERGENCY SITUATIONS IN TERMS OF SECTION 30A(1) OF NEMA

With regards to an emergency directive, note that:

- 1) It will be agreed to in terms of section 30A(1) of NEMA.
- 2) Notwithstanding a possible agreement to the emergency directive, any other applicable statutory requirement must still be complied with (e.g. any obligations under the National Water Act, 1998 (Act No. 36 of 1998), Regulations on Control of Use of Vehicles in the Coastal Zone, 2004 (GN R.1426) in terms of the Integrated Coastal Management Act, 2008 (Act No. 24 of 2008), the Conservation of Agricultural Resources Act, 1983 (Act No. 43 of 1983)), the Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002) or the National Heritage Resources Act, 1999 (Act No. 25 of 1999);

| 2. DESCRIPTION OF PROPOSED EMERGENCY WORKS TO BE UNDERTAKEN FOR  |

# THE SITE(S)

2.1 Provide the nature of the emergency situation, including the progression of the emergency (whether or not it has commenced/is imminent/has caused damage at the time of the request)

Due to recent floods in the area, the Transport Infrastructure Branch was notified that flood damages occurred along DR01433.

The damages include:

- Culvert structure(s) washed away completely.
- Erosion damage to the road layers at localised areas along the gravel road.

The state of the road was confirmed by an inspection.

2.2 Indicate the cause of the emergency situation; including confirmation of whether or not it was caused by the fault of the requestor

The cause of the emergency is due to recent flood events and was not the fault of the requestor.

2.3 Indicate the risk / probability of occurrence / severity of the impact on the environment as a result of the emergency; including an impact which may already have occurred

The proposal is to repair the damages to the river crossing structure(s) and reinstate the localised erosion along the gravel road.

2.4 Indicate the risk of the impact on human health and well-being as a result of the emergency; including any impact which may already have occurred

Due to the flood damage access and mobility in the area is affected. An alternative route is possible, but this route still utilizes a portion of the damaged road infrastructure. The current route is dangerous for pedestrian crossing.

2.5 Provide the measures to be taken; including proposed timeframes for actions and whether they will provide a temporary or permanent solution to the situation

The proposal is to repair the damages to the river crossing structure(s) and reinstate the localised erosion along the gravel road. This entails reconstruction of the culvert structure(s) and repairs to the gravel road layers at localised areas, in accordance with WCG standards, clearing of vegetation and eroded material, and the construction of erosion protection within the watercourse.

The total estimated construction period for all reinstatement works is approximately. six (6) months. This timeframe is a high level estimate and will be dependent on the design proposals.

2.6 What aspect of the emergency will each measure seek to address, and how?

A formal design must be done, but the major activities include:

- Constructing a temporary bypass for local access
- Excavating eroded material to a clean face and solid foundation;
- Demolition and removal of remainder of damaged causeway structure flood debris, and eroded road-embankment and pavement layers;
- Importing rockfill to create a solid base to on which to construct fill;
- Construction of replacement culvert structure(s);
- Reinstate road fill, pavement layers and roadway embankments;
- Erosion protection works. This includes gabion mattresses and baskets along the river route where required; and
- Installation of road signage where required.
