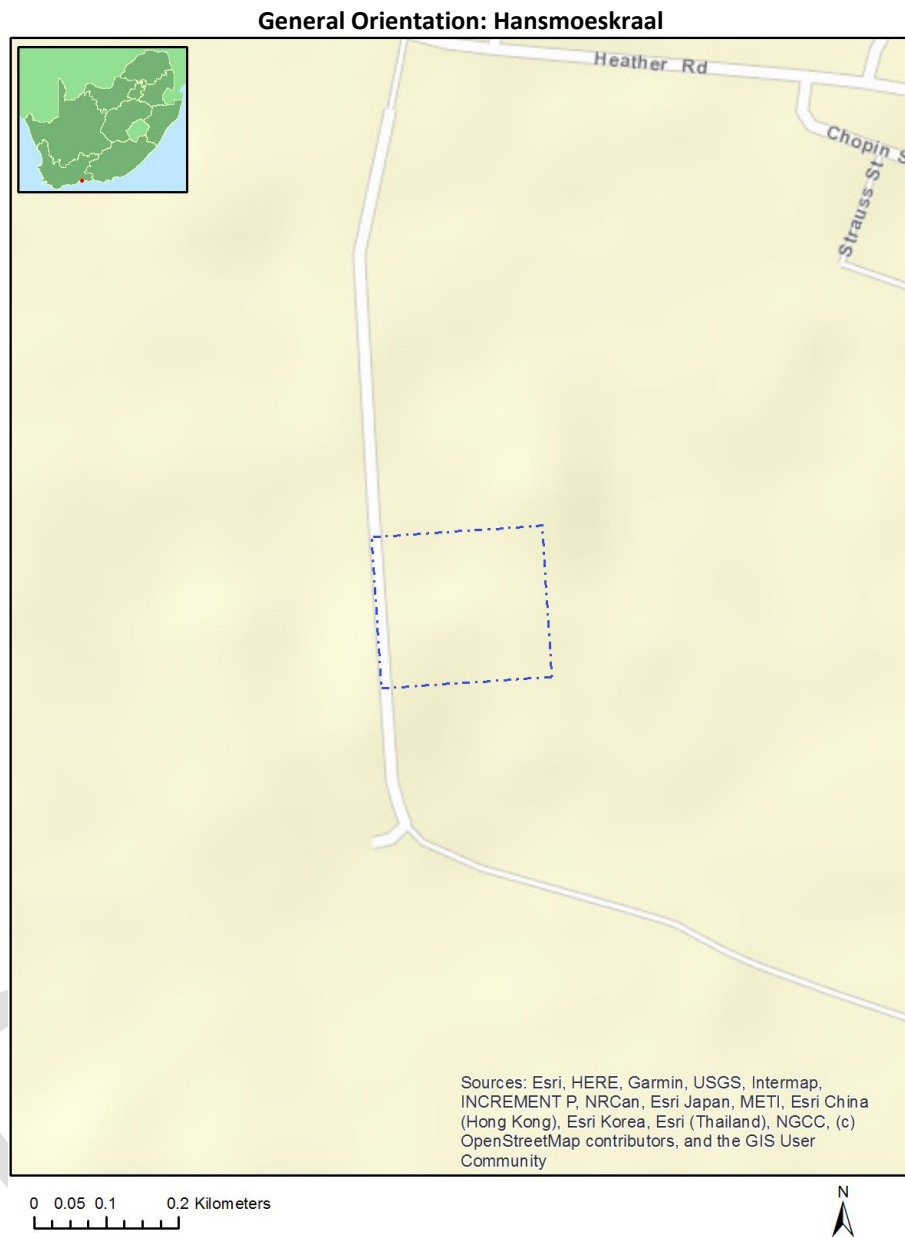

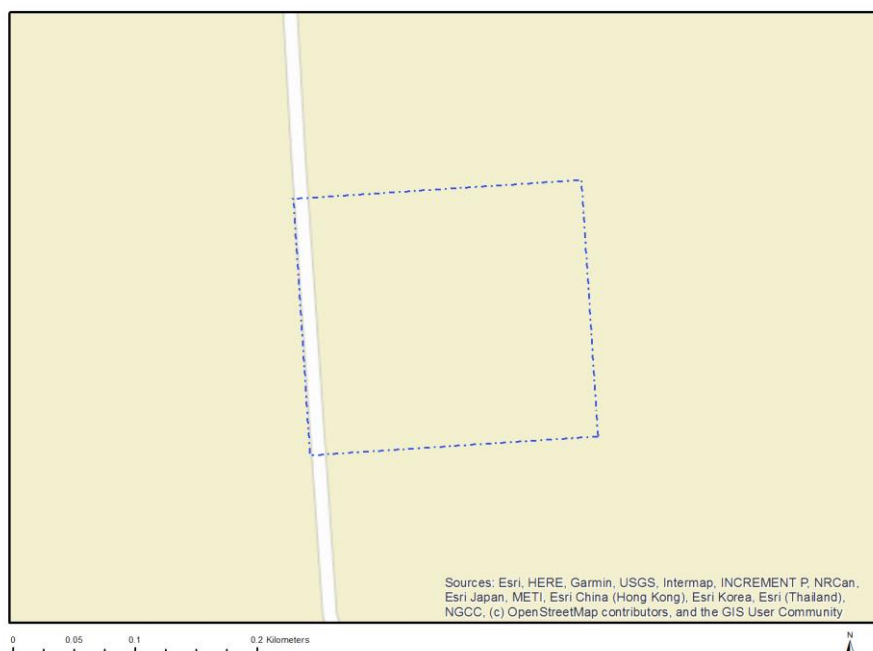

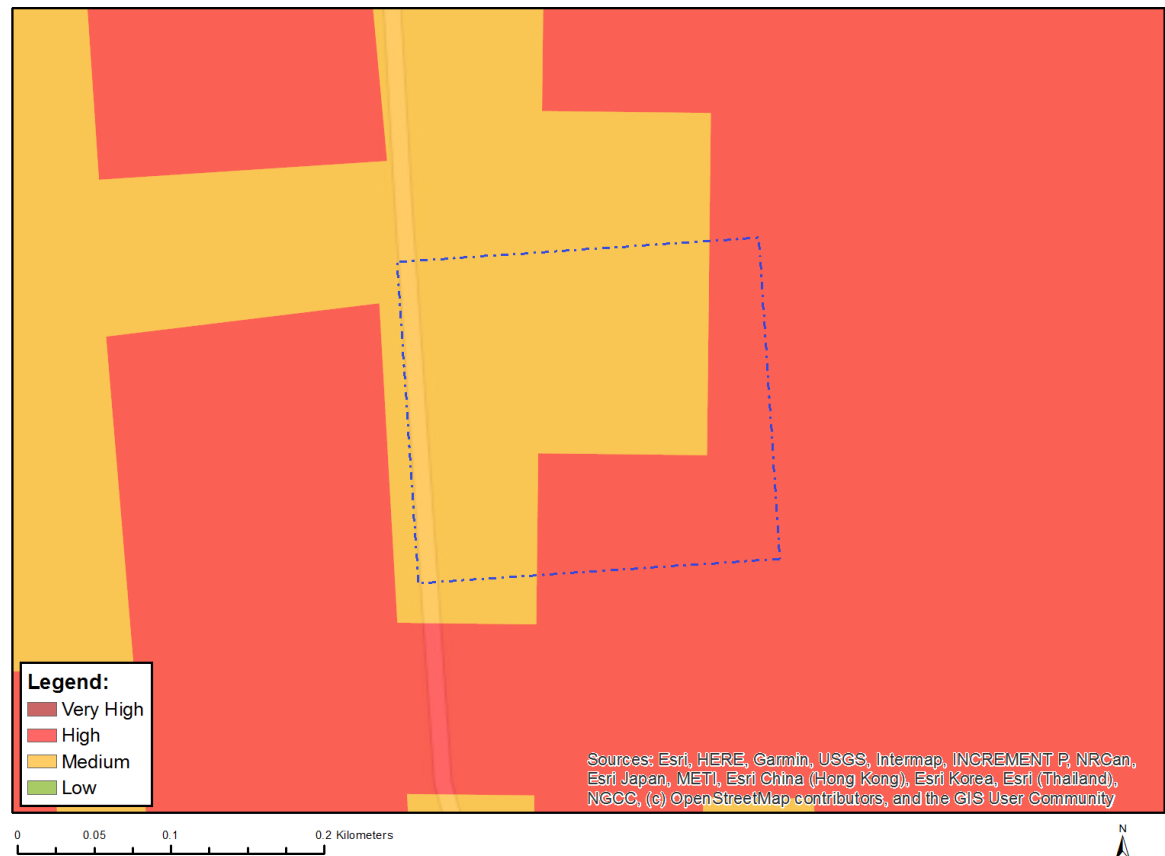

MAP OF RELATIVE AGRICULTURE THEME SENSITIVITY

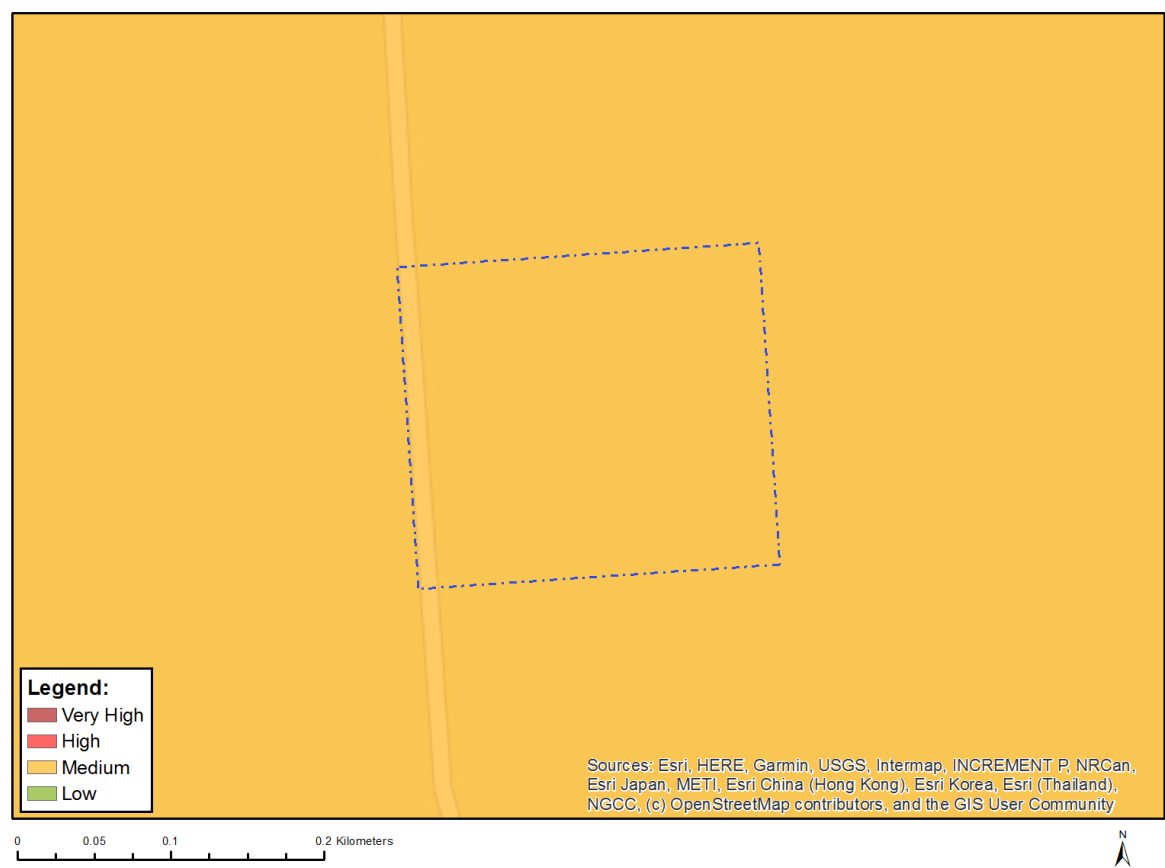

MAP OF RELATIVE CIVIL AVIATION THEME SENSITIVITY

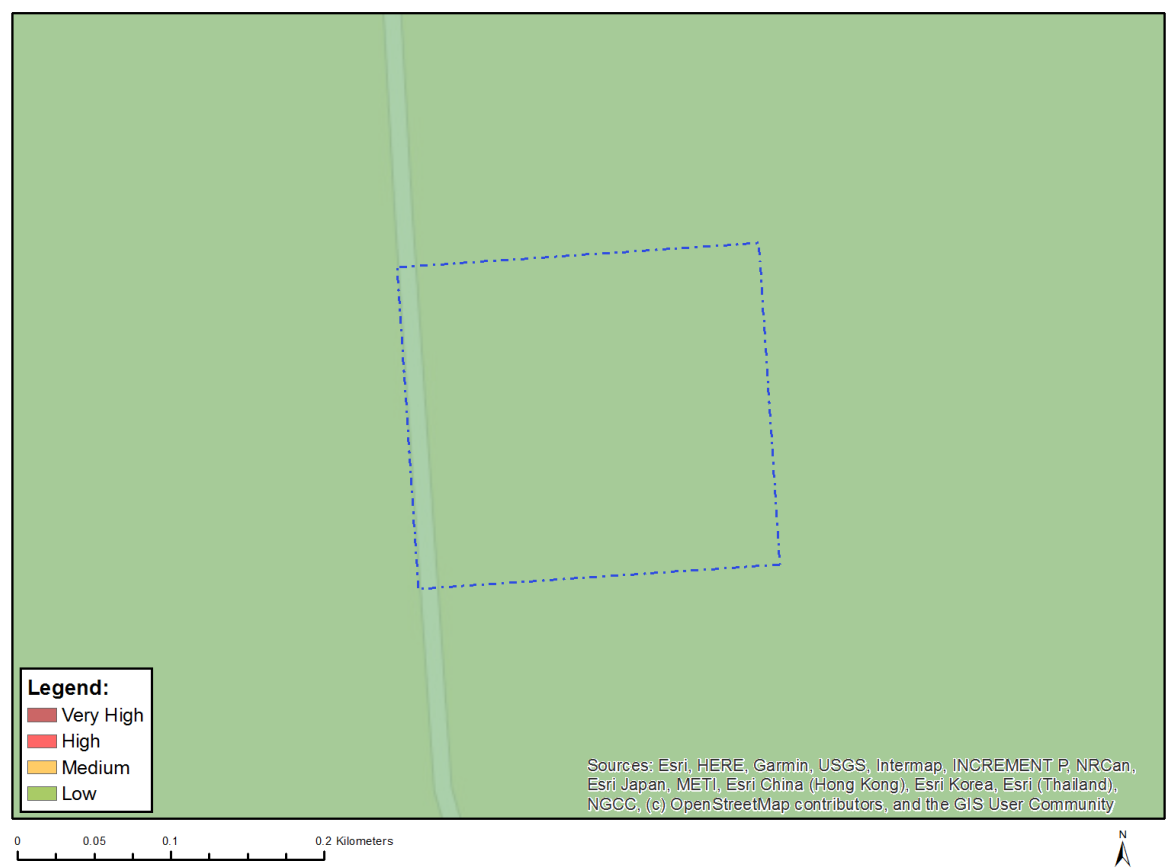
